Current Project (2014)

What else do you get from good security, beyond just good security?

In both corporate security departments and amongst security suppliers, there has been a very narrow focus on the benefits from services provided, in fact most often that focus has been on security benefits. But there is evidence that a host of other benefits are derived from having good security. For example, a study of security in the supply chain found the following:

- improved product safety
- improved inventory management
- improved supply chain visibility
- improved product handling
- process improvements
- more efficient customs clearance process
- speed improvements
- a reduction in problem identification time and higher customer satisfaction

This is just one example. But in fact there are a wide range of benefits that you get from a good corporate security function compared to a bad, and a good security supplier compared to a poor one. In this project we will catalogue both security benefits but also non security ones. For the first time ever we will be able to discuss the true value of security from an entirely new evidence base. Decisions on future projects will involve SRI members.

What does it involve and what does it cost?

Companies sign up for three years. Each year we undertake a study that develops new insights into security practice. Full details of previous projects are on our website, they include tool-kits on strategy development and procurement, and reports on the value of security and the state of the security sector.

You can be involved as much or as little as you wish. There are two meetings a year at which the Perpetuity team provide feedback. You are invited to these. Some members attend these and interact in between; others take a more back seat role. It is up to you. In any event we provide regular updates on progress.

The cost is £2,500 plus VAT for companies up to 250 employees and £5,000 plus VAT for bigger companies. That is the only cost.
